All should consider Honor Roll of DP3!

Guys, the PCN has over 2500 subscribers but a lot of retirees aren't members of the PCN. Nor does everyone get the DP3 emails. Many are not aware of this current extremely important battle about the PBGC BDL's. Please forward this message from me personally to urge them to re-engage. **THIS IS IMPORTANT!** I encourage all pilots to re-engage.

All PCN subscribers **please contact your pilot contacts** (some of whom are not connected to any network like the PCN) and let them know that this is important to them personally.

Bottom line is this - There is a chance to improve our PBGC monthly amounts (even over the possibility of a final determination "improvement" by the PBGC) via the appeal process. I am not promising that you will get more, but the fight is worth it. This appeal is being provided

for DP3 honor roll members by their chosen legal team from our dues. Becoming an honor roll member for one who hasn't paid any DP3 dues will cost \$1200. Now let's get serious. That is serious money. But two thoughts. One the DP3's string of efforts have been worth support. Secondly, if you improve a couple hundred a month, it would justify every penny. Individual appeals would likely be too complicated and too expensive. So this group effort is important to join. Tell your fellow "un-engaged" pilots to re-engage for this one. It's a battle worth waging.

Some ZEROes becoming HEROes!

I have heard from a friend a formally "zero" benefit PBGC recipient that he recently received his revised final BDL from the PBGC and now is receiving a \$600 monthly benefit. That is HUGE! Not only is the \$600 provide a little more monthly jingle, but my zero friend now qualifies for the all important 65% subsidy from the HCTC of the IRS to help on health care premiums.

I want to be clear on this. The zero guys that now get a benefit owe a lot of gratitude to the DP3 trustees who have fought hard on this very issue. I know that at times I am sounding like a DP3 cheerleader but I just want to recognize that there has been some recent progress that was fought hard for.

Mark's Remarks:

Two Things:

Appeal and Retrieving Numbers for filling out the DP3 Survey

Appeal your BDL: *Why wouldn't you?* See below the "Consolidated Appeal Process" What the PBGC is doling out is (in most cases) far below what you deserve. It is the formula used (not their fuzzy math) that unfairly reduces your monthly annuity for the bases of an appeal. The legal team stands ready and willing to appeal on that basis for any who desire. My question, why would you not desire to join in? You aren't jeopardizing your allotment you can only improve it. Why not try?

Retrieving Numbers for DP3 Legal Team (HRS) Survey: Listen, this is totally doable in fact downright easy. GET THIS SURVEY IN NOW, DON'T WAIT FOR YOUR BDL FROM THE PBGC.

The DP3 is organizing our group info for a group fight against the PBGC by the legal team. They need you to fill out two forms:

1. HRS = Honor Roll Survey (obviously this is for honor roll members of the DP3 and if you aren't it is time to at least consider it. Why not? Your legal representation is worth membership dues alone)
2. DOR = Designation of Representation. Simply a signature stating you want the selected legal team to represent you.

3. BDL = Benefit Determination Letter (Don't wait for this before you send in your survey, but when you get your BDL from the PBGC, send a copy of ALL pages in).

Now about the "HRS" and filling in the blanks. Easy as pie. You only need 3 dollar numbers and one you already know. The current PBGC payment to you is the 3rd request. Just fill in the gross amount. Now locate the gross amount of your retirement annuity value for the 1st request that you either originally got or was supposed to get. Then for the one in the middle just locate the gross amount of what Delta "re-calculated" your annuity to be (pre-termination) as of 9-1-06. With the addition of one kind of forgettable date (your seniority date –usually a few weeks after your hire date and easily found on any seniority list) you are set. Now, most of don't have your BDL letter from the PBGC yet, so fill in that box with four zeroes (0000). That is it! Still need help? Call the Delta ESC 800-MY-DELTA or email at ESC.Delta@Delta.com they can help with the first two numbers required.

Delta to start Seattle-Beijing service on June 4

Delta to start Seattle-Beijing service on June 4 after getting final Chinese gov't approval

On Tuesday May 18, 2010, 2:57 pm EDT

NEW YORK (AP) -- Delta Air Lines Inc., the world's largest airline, said Tuesday it will start nonstop service between Seattle and Beijing on June 4 after receiving final approval from the Chinese government.

The company had first announced the route as part of its international expansion plans in October.

Flights will operate five times per week. Flights will leave Seattle at 9:05 p.m. on Monday, Wednesday, Thursday, Friday and Saturday and arrive in Beijing at 11:40 p.m.

Flights departing Beijing will start June 6. They will leave the Chinese capital on Monday, Wednesday, Friday, Saturday and Sunday at 8:55 a.m. and arrive in Seattle at 5:30 a.m.

Because of the new route, Delta is adjusting the flight times for its Beijing to Tokyo route. The flight will now leave Beijing at 6:55 a.m. on Monday, Wednesday and Friday and at 7:30 a.m. on weekend days instead of the previous departure time of 8:55 a.m.

Mesa Air may lay off 500 after Delta wins ruling

Mesa Air says 500 layoffs possible after federal judge rules for Delta in long-running dispute

PHOENIX (AP) -- Mesa Air Group says it may have to lay off 500 workers at its Freedom Airline subsidiary after a federal judge ruled that Delta Air Lines has the right to cancel a service contract with the regional carrier.

Georgia-based U.S. District Judge Clarence E. Cooper ruled against Mesa on Monday in a long-running dispute with Delta. Mesa said it will leave 22 of its jets without work.

Cooper had prevented Delta Air Lines Inc. from canceling the \$20 million-a-month contract in June 2008. Delta said Phoenix-based Mesa Air Lines Inc. wasn't completing enough of its Delta Connection flights. But Mesa argued that was because Delta asked it to cancel many flights out of John F. Kennedy International Airport in New York during bad weather.

Cooper held a trial last month and reversed himself in his ruling Monday, siding with Atlanta-based Delta.

Delta Air CEO's \$1.3 Million Sale

Richard Anderson sold 100,000 shares of the airline.

SHARES OF CARRIERS SUCH as Delta Air Lines (ticker: DAL) are beginning to recover as the economy stabilizes and business travel returns. But recently, top insiders at Delta have been offloading shares, with the chief executive selling \$1.3 million worth.

CEO Richard Anderson sold 100,000 Delta shares at an average price of \$13.47 each on May 13. After the sale, he held 1.4 million shares directly and 1.2 million exercisable options, representing less than 1% of Delta's outstanding shares.

A Delta spokeswoman said an executive's decision to sell is a personal one.

Subject: "Donut Hole" With DALRC (Medicare) Prescriptions For 2010

Retired Pilots,

I paid \$62.50 for a 90 day prescription with MEDCO in February. I re-ordered this month and the same medicine was \$230.35. MEDCO said I had hit the "donut hole" (coverage gap) with Medicare prescription plans. I had never heard of a "donut hole" but I never attended the briefing last December. I got DALRC on the phone with MEDCO and found out the cost was correct. I had gotten within \$23 of the "donut hole" and this medication put me over. I will be spending the next \$1720 out of my pocket with no discount or co-pay, and then go into a \$2.40/\$6.00 co-pay.

All Medicare prescription plans are set up this way for 2010 but with DALRC, if you have the Emerald Plan, which I do, then I only pay half of the cost instead of the 100%. Had I been on the Opal Plan, the cost would have been \$460.70.

I was just passing this on in case you were unaware of this 2010 change in Medicare.

I was surprised I had paid that much this early in the year but found out the total wasn't just my cost, but what MEDCO says the drug is worth plus your co-pay.

BTW, the prescription I was taking was Caduet, a combination of Lipitor, for cholesterol, and Norvasc, for blood pressure. I was able to "separate" the Caduet and got a MEDCO prescription for the Lipitor that only costs \$125, and got the generic of Norvasc at my local Brookshire's Pharmacy for only \$9.99. So it saved me almost \$100 doing it that way. Similar generic programs are available at Kroger, Albertson's, Walmart, etc.

Hitting the Donut Hole

The donut hole, or coverage gap, is one of the most controversial parts of the Medicare Part D prescription drug benefit and of concern to many people who have joined a Part D drug plan.

Although all prescription drug plans must explain the coverage gap in their literature and advertising, the donut hole comes as a shock to many enrollees when they go abruptly from making [copayments](#) for their drugs to paying 100% of the cost.

How the Donut Hole Works in 2010

This is the standard Part D drug prescription plan for 2010 required by Medicare.

- If you join a Medicare prescription drug plan, you may have to pay up to the first \$310 of your drug costs. This is known as the deductible.
- During the initial coverage phase, your drug plan pays 75% of the covered prescription drug costs after your deductible is met, and you pay 25% until the total drug costs (including your deductible) reach \$2,830.
- Once you reach \$2,830 in total drug costs, you will be in the donut hole and you must pay the full cost of prescription drugs until your total out-of-pocket cost reaches \$4,550. This annual out-of-pocket spending amount includes your yearly deductible and copay amounts.
- When you spend more than \$4,550 out-of-pocket, the coverage gap ends and your drug plan pays most of the costs of your covered drugs for the remainder of the year. You will be responsible for a copay of \$2.40 for each generic drug and \$6.00 for other drugs (or 5%, whichever is higher). This is known as catastrophic coverage.

LATEST FINANCIAL REPORT ON THE DELTA PILOTS DISABILITY AND SURVIVORSHIP (D&S) PLAN

PLAN ASSETS FELL WELL BELOW BENEFIT OBLIGATIONS

The financial statements for the plan year that ended on June 30, 2009, indicate that the **assets** in the D&S Plan **were significantly less than the plan benefit obligations**. The Annual Return (Form 5500 and accompanying statements) filed on April 15, 2010, reveals the following changes in the status of the D&S Plan from the previous plan year.

Author's opinion: There may be some comfort in the fact that Delta now is defined as an additional source of payment of D&S Plan benefits. However, the D&S Plan assets (which are in the D&S Trust) are the ultimate security for plan benefits because such assets are reserved for distribution to plan participants and restricted from reversion to Delta, its creditors or shareholders.

Several years ago, the assets of the D&S Trust exceeded plan benefit obligations. As of June 30, 2009, **plan assets fell short of plan benefit obligations by more than \$575 million.** Although it is likely that the recent recovery in equity markets has favorably impacted the level of assets in the Plan (D&S Trust), it is unlikely that plan assets currently equal or exceed plan benefit obligations.

The "burn rate" of plan assets may subside somewhat beginning in 2011. If D&S Plan assets are less than \$1.2 billion, Delta will be required to make annual contributions to the Plan in the amount of 4% of free cash flow up to a maximum contribution of \$60 million (free cash flow would have to equal \$1.5 billion for that contribution to equal \$60 million). It would be more comforting to most retired Delta pilots if Delta were to cease drawing \$60 million annually from the D&S Trust to pay pilot sick and vacation pay.

Due to some recent attempts by DP3 members to directly contact Miller & Chevalier (the DP3 law firm handling the PBGC appeal for DP3) and the increased charges we incur for dealing with such contact, we are sending this notice to remind everyone of our policy regarding attorney-client contact between DP3 members and Miller & Chevalier.

DP3 completes an initial review of your appeal information and formats the data into consistent electronic files before forwarding the material to our attorneys. This process is designed to reduce the workload for the attorneys and save our members money.

Our policy is simple. All contact with Miller & Chevalier MUST come through a DP3 Trustee. All documents required to support the appeal must be sent to DP3, not to M&C. Please do not send the attorneys U.S. mail, faxes, or emails. Any such mail, fax or email sent directly to Miller & Chevalier will be ignored, returned, or discarded.

Please note that any contact with M&C made by individual DP3 members, Honor Roll or not, will be billed to you directly at M&Cs regular hourly rates.

PBGC Appeals Update from the DP3 Attorneys

The Consolidated Appeal Process

May 15, 2010

Our attorneys have reached an agreement with the PBGC Appeals Board for a **consolidated appeal process** for the retired DP3 pilots represented by Miller & Chevalier. The consolidated appeal date is tentative, but may become firm when the PBGC is able to determine the likely last date of Benefit Determination Letter (BDL) distribution. Basically, this means that everyone's appeal of their PBGC benefit will be dealt with on a group basis later in the year, once all BDL's have been sent and the last 45 day appeal deadline has passed. Our attorneys will simply extend the appeal deadline for each individual DP3 member until the consolidated appeal is ultimately filed.

It is extremely important for you to understand that our attorneys must seek individual extensions of time for each retired pilot after he/she has received his BDL and within the original 45-day appeal window - and therefore it is important that you send us the copy of the BDL as soon as you receive it. Don't forget to fax or email us your Declaration of Representation form, without which our attorneys cannot act on your behalf. Also, when you send a copy of your BDL, make sure you send us the entire BDL, including all cover pages.

Our attorneys will automatically handle filing the initial appeal and all extension requests as the consolidated appeal deadline approaches, so long as they receive your benefit determination information in a timely fashion.

Please note the membership status box adjacent to this article above left. The status box contains a yes/no indicator as to whether or not we have received your paperwork. This is the only acknowledgment you will receive that your forms have been received. *Please remember that records are entered manually so it may take several days for your status to be updated. If it has been more a week since submission and your information has not been updated, let us know. It is your responsibility to make sure we entered it in correctly.*

Sample Letter:

Dear Representative _____:

I am writing to ask that you to keep in H.R. 4213 the provision limiting the ability of companies opting for funding relief to use pension plan assets to make lump sum severance payments. I have heard that General Motors is opposing this limitation. GM, Chrysler, Alcatel-Lucent, Delta and other companies have proven untrustworthy to protect the interests of employees and retirees by using pension assets for non-pension expenses. I believe you have a public policy obligation to me to stop this!

GM reported a \$1.8 billion shortfall as of October 31, 2008, a deficit that had swollen far larger by February 2009. The Detroit Free Press reported that, GM and Chrysler admitted that, for the first time in their history, they were using pension assets to fund lump sum severance payments, ranging from \$45,000 to \$62,500, that would be paid in addition to workers' accrued retirement benefit. Alcatel-Lucent published in its 2003 10-K that they took \$2 billion. Delphi used this "back door reversions" practice and it contributed to the tragedy of many Delphi salaried retirees and placed the Pension Benefit Guaranty Corporation at risk. The PBGC took over the Delphi salaried pension plan, at 55% funded. These lump sum payments are bribes to induce early retirement and are business expenses, not pension benefits. If you don't understand the concepts, ask an accountant, FASB or the CBO.

Last month the Government Accountability Office reported that GM will need to add \$12.3 billion to its pension fund by 2014 and Chrysler will need to add \$2.62 billion. If those contributions aren't met, is the federal government going to step in and pay for the pensions of the 956,000 GM and Chrysler employees and retirees?

Does Congress want to offer funding relief to GM, Chrysler and others yet leave the door open for them during the funding relief period to simultaneously remove assets from the pension plan for corporate restructuring expenses?

You need to take action that is in the best interest of the constituents in your District who voted to send you to Congress to

take care of their business. I want to hear from you that you will do everything possible to include a provision in the House bill to protect pension plan assets for the benefit of retirees. I want action, not rhetoric and I need it now. Please do the right thing!

Subject: Blood Pressure

Mark, I read your review of the China trip with great interest. For some time I have been trying to sort out why my own BP can be quite high or ridiculously low. My guess is several things probably affected you? First the commute to China. This includes loss of sleep, airplane food with lots of salt+++, possibly flying tourist class and edging toward deep vein circulation issues, and last but not least some concern about getting the job.

For the most part my issues for the last 7 years have been personally connected. Being married to "Barbie" who is 25 years younger was a definite connection. Even when things seemed to be OK my brain knew better. LOL

I am writing you because of my experience last year in attempting to get a job as an air carrier inspector with the FAA. I was eventually disqualified because I had not flown 150 hours in the last 3 years. BTW a C-150 would have been OK according to the non flying type at the FAA. My comment was if I had done that they should not hire me because of a lack of common sense.

But I digress. The current Federal Flight Surgeon is a fanatic on BP. He believes it is the route of all evil. I went thru incredible screening because of a minimal dose of a water retention pill. They did everything possible to deny my First Class medical but in the end could not because a Cardiologist found no reason to think there was an underlying problem. They gave me the certificate with this restriction: It was good for only 6 months (no problem right?) Well the rub is it is not downgradeable to Second or Third class and I have to jump thru the hoops every 6 months with visits to the heart specialist and eye specialist who must do a full refraction and retinal examination. As John Denver would sing: "Some days are diamonds and some days are stones." If no one asks me about my Russian ex my BP is about 110/70.

Ask me first and then take it. 150/100. Same thing is the topic of Delta Air Lines and retirement comes up. 😊 All indicators point to living to 95. The bad news is all indicators point to living to 95. I am where I never wanted to be especially when married. "Never be worth more dead than alive. It gives people too much incentive for inappropriate actions."

So, check out the Federal Register and go after that FAA job. I quit the Navy Reserve thinking I did not need it after making CDR and satisfying my ego. What a huge mistake. Any Federal job would fill that square for a Federal retirement. Secondly some farm remedies seem to help with BP. Eating celery seems to have a beneficial effect. My Dad was in congestive heart failure and went on a total salt free diet. This is very difficult to do BTW. End result: He has lost over 25 pounds, BP is 120/75, 85 in October and they now think he will make 100 if they can fix an aortic heart valve without cracking his chest.

Be careful what a well meaning "Family" doctor might write for you. Check it out with a Flight Surgeon if you have any doubt.

Comments - DALRC INSURANCE USERS BE CAREFUL

Having been retired for 13 years, and having lost my pension along with everyone else, I do not have a lot of trust in Delta Air Lines. Thus when I remarried last month and desired to get my wife (under 65) enrolled in the Delta Medical Insurance plan, I attempted to cross all the T's and dot all the i's. I checked with the ESU and told them my circumstances (retired, DALRC insurance, etc) I was told after several phone conversations that my prospective spouse would be covered were I to do all the necessary paperwork in a timely manner. After doing all this I have been informed that the DALRC insurance does not count as insurance and they (ESU) was sorry for the inconvenience but my new wife was not eligible for coverage by Delta and since I had married her without being on the DPMP she would never be eligible for this coverage. Although Delta subsidizes the DALRC insurance program and offers it each enrollment period, Delta does not consider it as a Delta sponsored insurance program.

I have called the VP of Human Resources as well as his assistant and neither have bothered to call back.

Does anyone know of any way to address this problem other than the appeal which I have submitted? If so, please let me know at stevegrice@comcast.net.
